- Contextualization and Localization are two key concepts in the Philippine Kto12
 Curriculum that is crucial in engaging students in the teaching-learning process.
- 2. In its desire to improve the performance of all schools through maximum engagement of students in the teaching-learning process, the Division of Zamboanga del Norte will conduct a Three-Day Live-In Seminar-Workshop on the Facilitation of Contextualization of the Curriculum on December 20-22, 2016 at Top Plaza Hotel and Mibang Hotel.
