

- 6. The research presenters will be given Php. 3,000.00 as an incentive to be charged against the Basic Education Research Fund (BERF).
- 7. The travel and incidental expenses incurred by the participants in the Division Research Congress and August 29, 2017 meeting will be charged against school MOOE for the district research focal person and SDO funds for the PSDS's subject to the usual government accounting and auditing procedure.
