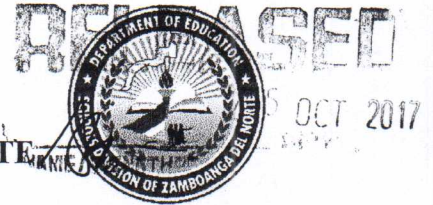

Date : **October 23, 2017**

1. As mandated in DepEd Memorandum No.163, s 2017, The Department of Education (DepEd), through the Bureau of Education Assessment (BEA) with the assistance of Schools Division and Public Secondary schools personnel, this division will administer the **Test in English Proficiency for Teachers (TEPT) and the Process Skills Test (PST) in Science and Mathematics** on October 29, 2017 at Katipunan National High School, Katipunan, Zamboanga del Norte.
2. The TEPT- PST will be administered to all Grades 9 and 10 Public School teachers in Science and Mathematics.
3. In the conduct of the TEPT-PST, the teacher-examinees shall be given one day service credit as provided in *DepEd Order No. 53, s 2003* entitled *Updated Guidelines on Grant of Vacation Service Credits to Teachers*.
4. Teachers, who already took the recently concluded TEPT-PST for Grades 7 and 8 and are also teaching Grades 9 and 10 Science and Mathematics subjects need not take the forthcoming TEPT-PST.
5. The **BEA** representative will conduct the orientation for the Chief Examiner, Room Supervisors and Room Examiners on the day of the test. Refer to the list of the Room Supervisors/Examiners as enclosed.
6. Travel and other incidental expenses shall be charged against local funds subject to the usual accounting and auditing rules and regulations.
7. Immediate dissemination of this Memorandum is desired.
