The Schools Division of Zamboanga del Norte will conduct a Two- Day Live- In Activity on U4U Training of Trainers cum Orientation to Adolescent Health and Youth Development (AHYD) for Public Schools District Supervisors, Master Teachers and District Guidance Coordinators and a Review on DepEd Order No. 40, s. 2012 DepEd Child Protection Policy on September 26-27, 2017 at Top Plaza Hotel, Dipolog City.

The objectives of the activity are the following:

1 Effective facilitation of U4U for Secondary Guidance Counselors/ Advocates;

2. Comprehensive information on the status of the Youth in Zambonga Peninsula and Adolescent Health and Youth Development (AHYD) Program;

3. Be reoriented with DO 40, s. 2012 DepEd Child Protection Policy; and

4. Create a working guidance committee in the district, clustered district and division levels.

Expected participants shall be from the District Guidance Committee which includes: 35 Public Schools District Supervisors, 35 elementary Master Teachers (preferably a Values Education Coordinator), 35 District Guidance Coordinators and 35 Guidance Counselors/ Advocates of the Main Secondary Schools (Please see attached sheets). The guidance counselors of Sindangan NAS and Polanco NHS are requested to assist in the facilitation of this activity. Check-in date to the venue will be on September 26, 2017.

The District Guidance Committee are required to bring and submit the School Child Protection Policy and composition of the School Child Protection Committee of every school in their respective districts as well as the Workplan on the establishment of the School-Based Teen Centers from the secondary schools.

Expenses incurred during the activity which includes food and accommodation, training supplies and materials shall be chargeable against Division HRTD Funds. Travel and other incidental expenses of the participants shall be charged to Division Local Funds (PSDS)/ School MOOE (SHs, MTs, GCs) subject to the usual accounting and auditing rules and regulations.
