1. In the exercise of reasonable supervision over the operation of private/non-DepEd schools, and in the pursuit of continuous education to key stakeholders particularly with regard the implementation of Senior High School and its ancillary programs in this school division, this Office hereby announces the conduct of the Two (2)-Day Live-Out School Management Monitoring and Evaluation Updating and Conference with the Private School Administrators and the Education Supervisors 2018, on July 5 -6, 2018, at Sindangan National Agricultural, Goleo, Sindangan, Zamboanga Del Norte.

- 2. The objectives of the convergence are as follows:
 - i. To re-orient the identified participants on the salient and amended provisions of the Manual of Regulations for Private Schools in Basic Education, and the recent DepEd issuances relevant to the topical
 - ii. To provide technical guidance on the updated and customized requirements for the applications of Government Permit, Gov't Recognition, Renewal of Permit/Recognition, School Fees Increase, Summer Classes, Special Order, and Assessment of Student from Abroad, including the updates on EBEIS-LIS registration/enrolment;
 - iii. To thresh out latest issues in the implementation of the Senior High School Program, the SHS Voucher Program, and JDVP-TVL combinations, as well as those in Kindergarten;
 - To strengthen the public-private partnership in the matters of K to 12 iv. Curriculum Implementation and Governance.

- 3. Expected to attend are the following identified participants:
 - i. School Administrators/School Heads from the forty-five (45) recognized private/ non-DepEd schools operating in this division;
 - ii. The thirty-five (35) Public Schools District Supervisors;
 - iii. Division Education Program Supervisors (to attend in the **Second Day only**, except those who are tapped as resource persons with topic in the 1^{st} day);
 - iv. The second representative from the private schools (45 in all), who is preferably the school ICT in-charge or the school registrar, to deal with the EBEIS-LIS matters. (to attend **the first day sessions** only).
- 4. NO REGISTRATION FEE SHALL BE REQUIRED. In no case shall each private school send MORE THAN two (2) representatives, unless otherwise prior permission and consent by the Division is secured upon request, citing thereon an exceptional circumstance which merits consideration for additional representation. Private school participants are ENCOURAGED to bring laptop and MODEM to better facilitate the online activity.
- 5. Attached hereto is a copy of the matrix of activities for your information and guidance.
- 6. Travel expenses which may be incurred in by the concerned Division personnel shall be chargeable against the Division Funds, subject to the existing accounting and auditing rules and regulations. Travel and other incidental expenses of the participants from the private/non-DepEd schools shall be charged against their respective local funds.
- 7. Immediate and wide dissemination of this Memorandum is desired.
