Subject: SUBMISSION OF REPORT OF ACTIVITIES ON THE OBSERVANCE OF THE 40th NATIONAL DISABILITY PREVENTION AND REHABILITATION (NDPR) WEEK

Date : July 16, 2018

1. Presidential Proclamation No. 361 series 2000 declaring the observance on the annual celebration of the **National Disability Prevention and Rehabilitation (NDPR) Week** for this year on July 17-23, 2018 with the theme "*Kakayahang at Kasanayan Para sa Kabuhayan Tungo sa Kaunlaran*" which focuses on the realization of the fundamental freedom and rights of persons with disabilities as provided for in existing international mandates and national laws.
2. This year's celebration aims to stimulate public awareness on the issues and problems of disability and encourage every citizen to take active responsibility in uplifting the economic and social conditions, as well as recognizing the abilities of persons with disabilities in the country.
3. The following activities are hereby suggested to be undertaken by all implementing schools of SPED program:
 - a. Hanging of advocacy streamers in conspicuous places of schools,
 - b. Participation to the activities organized by the Local Government Units (LGUs) and other Non-Government Organizations (NGOs), and
 - c. Submission of report after the culmination of the activity.
4. The schools can select appropriate activities which can be conducted at the school and are relevant to the theme of this year's celebration. However, all activities to be undertaken should not disrupt classes nor compromise their supervision pursuant to DepEd Order No. s. 2005 entitled **Instituting Measures to Increase Engaged Time-on-Task and Ensuring Compliance Therewith**.
4. Relative to this, all implementing schools and centers of Special Education (SPED) program of this division shall submit reports on the conduct of activities in celebrating the NDPR Week which include pictorials through the email address zarcelita@yahoo.com on or before July 31, 2018 to this office for submission to the regional and central office using the template below :
