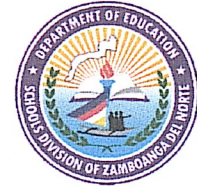

Pursuant to DepEd Order No. 47 series of 2014 entitled *Constitution and By-Laws of the Supreme Pupil Government (SPG) and Supreme Student Government (SSG) in Elementary and Secondary Schools* and DepEd Order No. 11, series of 2016 "Additional Guidelines to the DepEd Order No. 47, series of 2014, the division will conduct a forum with the student leaders and advisers on September 18, 2018, 8:00AM at Sindangan National Agricultural School, Goleo, Sindangan, Zamboanga del Norte. Participants are the district-federated SSG/ SPG Presidents and their advisers.
