1. To strengthen the implementation of the DepEd issuances on Child Protection, such as *DepEd Order No. 55, s. 2013 (Implementation Rules and Regulations of the Anti-Bullying Act of 2013)*, *DepEd Order No. 40, s. 2012 (DepEd Child Protection Policy)* and *DepEd Order No. 18, s. 2015 (DepEd Guidelines and Procedures on the Management of Children at Risk (CAR) and Children in Conflict with the Law (CICL))*, the division will conduct a 2-day live-in seminar workshop on May 21- 23, 2018 at Top Plaza Hotel, Dipolog City. Registration starts at 12 noon of May 21, 2018 and ends at 5:00 PM of May 23, 2018.
2. The division rollout for Child Protection aims to equip the participants with the knowledge, skills and attitudes to provide the necessary assistance to the schools in all districts. It is expected that at the end of the training, the participants will be able to efficiently assist and ensure school compliance to all the requirements laid by the aforementioned DepEd issuances and other laws related to child protection.
3. The participants to this rollout are the 35 District Guidance Coordinators (Elementary) and 35 Secondary Guidance Counselors/ Advocates and 3 Project Development Officers I (Division Youth Formation Officers). Please see attached list of schools for reference.
4. Participants to this activity are entitled to earn leave credits as per DepEd Order No. 53, s. 2003 *Updated Guidelines on Grant of Vacation Service Credits to Teachers*.
5. Accommodation and meals will be charged against Division GAD Funds while their transportation and other incidental expenses shall be charged against School Local Funds, subject to the usual accounting and auditing rules and regulations.
