- In line with our sincerest intention to make the services of the schools division office
 accessible and available at the district level, this office hereby directs all Public
 Schools District Supervisors to organize and form the District Social Mobilization and
 Networking Committee, which shall act as the district partnership hub and shall
 cater to the partnership needs of the schools and district.
- The District Social Mobilization and Networking Committee shall have the following composition:
 - a. Chairperson the Public Schools District Supervisor, as educational leader and manager of the district, shall automatically sit as the Chairperson of the committee;
 - Co-Chairperson preferably a school head whom the chairperson has full trust and confidence, is knowledgeable on partnership building, can excellently facilitate committee meetings and can make outstanding representation for and in behalf of the chairperson; and
 - Members all school heads of the district.
- The formation of the District Social Mobilization and Networking Committee is aimed at providing the schools and learning centers the many advantages and benefits that may be enjoyed from the partnership efforts, and in one way or another, help address the most pressing needs of the schools and learning centers.

For reference, the District Social Mobilization and Networking Committee is responsible for:

- Preparation, consolidation and repository of the Directory of Local Stakeholders/ Partners and Profile of School Resource Gaps;
- Identification of partners to support DepEd programs, projects and activities to be held at the district level;
- f. Preparation, collection and repository of partnership advocacy materials;

- g. Preparation and repository of the Draft Partnership Proposals and Memoranda of Agreement (in consultation with the Division Legal Counsel);
- Preparation (serve as clearing house), consolidation and repository of feedback reports, periodic progress reports, and accomplishment reports of programs, projects and activities funded and/or sponsored by external stakeholders; and
- Provision of technical assistance to schools by responding to the identified needs in relation to social mobilization.

- An orientation cum capability building session for the members of the committee will be conducted to ensure understanding and cooperation from all the concerned beginning first week of April 2018.
