Subject: ADDENDUM TO DIVISION MEMORANDUM DATED JANUARY 3, 2019 ENTITLED "2018-2019 SEARCH FOR OUTSTANDING READING TEACHER FOR ELEMENTARY AND SECONDARY LEVELS (GRADE 4 & GRADE 9; T1-T3 & MT CATEGORIES)".

1. This is to remind the concerned PSDSs, elementary and secondary school heads and all the SORT contestants that the Division level competition will be held on March 8, 2019 at Roxas CS for elementary while the secondary level will be held at Langatian National High School.

- 2. As regards the composition of the Panel of Observers for Demonstration Teaching in the Division Level, the host schools are advised to prepare two (2) preparation rooms and two (2) demonstration rooms. One room for the T1-T3 category and a separate room for the MT category.
- 3. Hence, we need two (2) sets of observers from the previously five (5) members, one (1) will be added for the elementary level and one (1) will be added for the secondary level. The six (6) members will be divided into two (2). Three (3) members will observe in the T1-T3 category and another three (3) will observe in the MT category.
