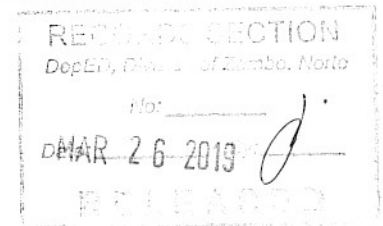

1. Pursuant to DepEd Order No. 53 s. 2016, and DepEd Order no. 7, s. 2015, which stipulate the *Hiring Guidelines for Senior High School and Kindergarten to Grade 10 Teaching Positions*, this office hereby announces the conduct of the English Proficiency Test (EPT) on **March 31, 2019** at the **Katipunan National High School**, Katipunan, Zamboanga Del Norte;
2. The test shall be administered in three (3) batches. Hereto attached is the list of division and field personnel who are tapped to serve in specific capacities for the conduct of the EPT, for your information and guidance;
3. Qualified to take the test are as follows:
 - i. *New applicants as listed in the Registry Qualified Applicants for 2019-2020;*
 - ii. *Old applicants, **except those who took the 2018 EPT**, since their rating can still be used or applied this year;*
4. All EPT takers are expected to be in the testing venue on or before 7:00 A.M. Takers are asked to bring pencil, eraser, and snack/lunch packs. Walk-in applicant-takers or applicant-takers from other division will not be entertained;
5. The host school shall be responsible for the preparation of fourteen (14) testing rooms, a waiting space for takers, a room for the TWG, as well as the sound system. The host school may cover the expenses for documentation and the provisions of snacks and lunch for the testing personnel and the TWG members, from the local school fund, subject to the usual accounting and auditing rules and regulations;
6. Service credits or compensatory time-off, as the case may be, shall be granted to DepEd personnel who shall have rendered their services in the conduct of the EPT.
7. Travel expenses that may be incurred in by the testing personnel and TWG embers shall be charged against division MOOE or local school funds, subject to the usual auditing and accounting rules and regulations.
8. Prompt and wide dissemination of this Memorandum is desired.
