1. The National Government continuously assesses the Nutritional Level among Filipino children for the implementation of the appropriate interventions. Nutritional Status (NS) has evolved to become the key source of data not just on nutrition-related information but on health matters as well.
2. This office directly calling the non-compliant District/Schools on the submission of the Yearly Consolidated Nutritional Status Report **Endline SY 2018-2019** on or before **May 3, 2019** pursuant to DM 165, s. 2010 using the new BMI software with height-for-age (HFA) format from the software. Attached herewith are list of Non-compliant Districts. *(Refer to Annex A)*
3. For **SY 2019-2020**, **baseline** weighing of all learners must be done during the Brigada Eskwela and submission of report is expected not later than **June 14, 2019** ready for the mapping of SBFP.
