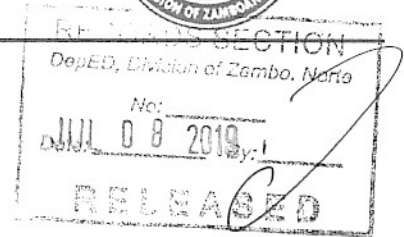

SUBJECT: **CAPACITY BUILDING OF PUBLIC SCHOOLS DISTRICT SUPERVISORS AND SELECTED SECONDARY SCHOOL PRINCIPALS ON TECHNICAL ASSISTANCE FOR THE IPED IMPLEMENTING SCHOOLS**

1. Pursuant to the directions set by DepED Order No. 62,s.2011 , as well as to support those who are serving in IP communities in developing knowledge, skills, and attitudes needed to implement the vision of a culture-responsive and community-based K to 12 curriculum, this Division will conduct the **Two- Day Capacity Building of PSDSs and Selected Secondary School Principals on Technical Assistance for the IPED Implementing Schools on July 24 (1:00 PM) to July 26, 2019 at Top Plaza Hotel, Dipolog City.**

2. At the end of the activity the participants will be able to;

- Develop a holistic perspective on the overall learning and socio-cultural context of Indigenous Cultural Communities.
- To develop knowledge, skills and attitudes needed by Teachers, School Administrators and DepEd Personnel for them to become an effective IPED Implementers/Managers.
- Develop a plan for the Technical Assistance to schools implementing IPED.

3. The participants of this training are the Public Schools District Supervisors, selected Secondary School Principals as identified in the list attached herewith and are requested to bring the appropriate **Indigenous Peoples attire (Subanon or Kolibugan)** to be worn during the Opening Program.

4. Participants are expected to arrive at the venue on or before **1:00 PM of day 0, July 24, 2019** for the registration/settling in of rooms in the hotel. The program and session proper shall then commence at exactly **2:00 PM.**

5. Facilitators and staff are advised to be in the venue at 8:30 AM of **July 24, 2019** for the preliminary activities and debriefing.

6. Meals and accommodation, fare and honoraria of IP Elders/Resource Persons and non-DepEd Resource Speakers, travel expenses of facilitators coming from the schools/districts, supplies & materials and other expenses relevant to the conduct of the said activity are chargeable against the Division IPED Program Support Funds while travel expenses of the PSDSs are chargeable against the Division Funds and the Secondary School Principals against local funds/MOOE subject to the usual accounting, auditing rules and procedures.
