This is to announce the new schedule for the administration of English Proficiency Test (EPT) in this division which is **November 10, 2019**, at Katipunan National High School, Katipunan, Zamboanga Del Norte. - The official list of EPT registrant-examinees will be posted in the bulletin of information in the testing school a day before the test date, and may be accessed in this link bit.ly/zneptregistrants2019, starting November 1, 2019;
- 3. Examinees are directed to come before 7:00 AM of November 10, 2019, and bring the following:
 - a. EPT admission slip, and
 - b. Mongol 2 pencil/s.
- 4. The list of testing personnel who will serve during the administration of the EPT is herewith annexed, for information, guidance and adherence. The herein identified room examiners and room supervisors MUST come on or before 6:15 AM on the date of the test, for the BEA-led briefing and distribution of materials;
- 5. Travel expenses which may be incurred in by the concerned testing personnel during the test administration shall be chargeable against the local funds/School MOOE or division MOOE, as the case may be, subject to the usual accounting and auditing rules and regulations. The host school may cover from the school local funds, the expenses that may be incurred in for the provisions of food to testing personnel and TWG members, subject to the availability of funds and the COA auditing and accounting rules and regulations;
- 6. Per, Joint CSC-DBM Circular No. 2, s. 2004, service credits or the Compensatory Overtime Credit, as the case may be, shall be given to the division and field personnel who may have served beyond the official time during which the test administration or its preparatory/ancillary activity is done;
