

The Department of Education Region IX through the Quality Assurance Division (QAD) in coordination with the ZAMBASULTAPS will conduct a Two-Day Exit Conference for Private Schools Operation on November 19-20,2019 at Celebrity Hall, Astoria Hotel, Mayor Jaldon Street, Zamboanga City.

2. The conference aims to:

- A. Provide information on SHS Work Immersion, TVL Combinations ,SHS Unique Track, and its approved specialization, Exit Exam (BEEA),NAT, NCAE and PEPT for Grade 12,Grade 10, Grade 6 and Grade 9 students/pupils conducted by BEA, and proposed TVL Exhibit Display, etc..
- B. Review Dep .Ed Order No.55, s.2016 Policy Guidelines on National Assessment of Students Learning for the K to 12 Basic Education.
- C. Present requirements, procedures, guidelines, policies and flows in any QAD transaction.
- D. Give emphasis on timeline, completeness and accuracy of documents for Submission.
- E. Other matters
- Participants are the Private Schools and SHS Coordinators of the Division, and School Heads of SUCs /LUCs, HEIs and TVIs. They are expected to arrive in the morning of Nov.20, 2019. Opening program will start at 1:00 0 clock in the afternoon of the same day and follows the conference proper.
