Sir:

Through the years, Schools Division of Zamboanga del Norte has been extending support to Zamboanga del Norte Electric Cooperative, Inc. (ZANECO for brevity) especially during the conduct of District Elections for ZANECO Board of Directors. We are very grateful indeed.

Today ZANECO will once again conduct its District Elections for the following districts, to wit;

- District II – Municipalities of La Libertad, Mutia and Sergio Osmena;
- District IV – Municipalities of Polanco and Pinan;
- District VII – Municipalities of Katipunan, Roxas, Manukan and Jose Dalman;
- District VIII – Municipalities Sindangan, Siayan and Leon B. Postigo;
- District IX – Municipalities of Salug, Godod, Liloy and Tampilisan; and
- District X – Municipalities of Labason, Gutalac and Kalawit.

Elections, pursuant to the National Electrification Administration (NEA) approved schedule shall take place on 7 December 2019 (Saturday) for Districts II and IV and 14 December 2019 (Saturday) for Districts VII, VIII, IX and X. Said undertaking be particularly conducted at the following central schools, namely:

- La Libertad Central School
 - Bajo (Sergio Osmena) Central School
 - Mutia Central School
 - Polanco Central School
 - Pinan Central School
 - Katipunan Central School for District VII;
 - Sindangan Pilot Demonstration School for District VIII
- } for District II
- } for District IV

With this, we are asking your usual approval to allow us to use **four (4) classrooms** for each central school of Districts II, VII, VIII, IX and X to be utilized as our voting precincts and **three teachers** each voting precinct to compose the Precinct Election Committee (PECOM). Considering however, the number of member – consumer – owners voting for **District IV**, we are most respectfully appealing your approval to allow us to use **six (6) classrooms** in **Pinan Central School** and **Polanco Central School** with the same number of teachers per precinct to compose the Precinct Election Committee (PECOM), respectively. Let the undersigned show the tabular summary, to be as follows:

ZANECO will be providing back and forth transportation, meals and snacks during the briefing, days before election and honoraria, back and forth transportation, meals and snacks during the election day.

Elections will start at 8:00 o'clock in the morning up to 3:00 o'clock in the afternoon of the same dates. Their presence is also needed during the final canvassing of ballots to take place in Dipolog Main Office, Gen. Luna St., Central Barangay, Dipolog City for **District II**, **District IV** and **District VII**. For **District VIII** final canvassing will be at ZANECO Sindangan Area Services, while **Districts IX and X** will be at Liloy Area Services.

Counting the election period which is only 20 days, we are still positive that this undertaking will be crowned with ultimate success, with you as our main actor of the play.
