Executive Order No. ______A Series of 2020

"AMENDMENTS TO THE SECTIONS 3.1, 7 & 8 OF EXECUTIVE ORDER NO 20-75"

WHEREAS, neighboring provinces of Zamboanga del Norte have been placed under Modified Enhanced Community Quarantine due to reported cases of local transmission in their community;

WHEREAS, there is a need to provide additional stringent measures to prevent the spread of COVID19 in the Province;

NOW, THEREFORE, I, ROBERTO Y. UY, Governor of the Province of Zamboanga del Norte, by virtue of the powers vested in me by the Local Government Code and such other laws, do hereby order:

Section 1. Section 3.1 of Executive Order No. 20-75 is amended as follows:

"3.1 **Persons Allowed to Enter the Province.** The following persons shall be permitted entry into the Province of Zamboanga del Norte, provided, that the following requirements are complied with, **(EXCEPT** those persons who are <u>transiting through</u> and/or his/her place of origin is an area placed under Enhanced Community Quarantine (ECQ), Modified Enhanced Community Quarantine (MECQ), or any form of Lockdown and those persons whose <u>place of destination have existing travel moratoriums</u> issued by the DILG and/or declared by the respective LGU), *viz:*

NOTE:

- The movement of people across areas placed under any form of community quarantine for leisure purposes shall NOT be allowed.
- Travel permits shall only be issued for any purpose other than for leisure.
- Personnel of delivery vehicles for goods, cargo, trucking and courier services from an ECQ and MECQ areas shall be permitted entry into the province pursuant to Section 7 (1) of the Omnibus Guidelines on the Implementation of Community Quarantine.
- All persons allowed entry into the Province are mandated to download/register in the StaySafe App and fill up the PIATF Declaration Form. Airlines, bus lines, and shipping lines may adopt measures to ensure compliance to the said mandate.
- All persons who are only passing through the Province shall be provided with a "NO STOPPING" sticker which shall be placed in the windshield or any conspicuous space in the vehicle as an indication that the said vehicle is not authorized to make any stopovers in the Province.

Section 2. Section 7 of Executive Order No. 20-75 is amended to include the following paragraph, viz:

"Business establishments are required to conduct a random rapid testing to its employees once a month. The results of the rapid testing shall be reported to the

Section 3. Section 8 of Executive Order No. 20-75 is amended to include the following paragraph, viz:

"Public and private offices are required to conduct a random rapid testing to its employees once a month. The results of the rapid testing shall be reported to the concerned City/Municipal Health Officer for evaluation and/or appropriate action."

Section 4. This executive order shall take effect on September 14, 2020.

Executive Order No. 20-75-3 Series of 2020

"AMENDMENT: TO ITEM (5), SECTION 3.1 OF EXECUTIVE ORDER NO 20-75"

WHEREAS, the Province of Zamboanga del Norte has recorded its first case of local transmission from the Municipality of Sibuco;

WHEREAS, the aforesaid case is an Authorized Person Outside Residence (APOR) working in the Province who regularly travels in and out of the Province;

WHEREAS, there is high probability of COVID-19 transmission from APORs considering that they are not required to undergo a mandatory 14-day quarantine when the duration of travel does not exceed 48 hours;

WHEREAS, there is a need to address this matter and provide additional stringent measures in accordance with existing national guidelines to prevent the further spread of COVID-19 in the Province;

NOW, THEREFORE, I, ROBERTO Y. UY, Governor of the Province of Zamboanga del Norte, by virtue of the powers vested in me by the Local Government Code and such other laws, do hereby order:

Section 1. Item (5), Section 3.1 of Executive Order No. 20-75 is hereby amended as follows:
