# APPROVAL TO DISTRIBUTE DepED LEARNING MATERIALS

## TO WHOM IT MAY CONCERN:

Given that the classes Nationwide has been postponed several times and to facilitate the reopening of classes virtually with the principle that **EDUCATION IN EMERGENCIES must continue**, This is to **GRANT** the request of the Department of Education Division of Zamboanga del Norte to distribute Learning Materials within School Premises and identified Porok Centers, provided that a planned scheme of distribution is prepared.

Approval is also **GRANTED** for as long as all Teachers, Parents and Students who are to receive the Learning Materials must observe the proper health standards and protocols as prescribed by the National Inter Agency Task Force and the Provincial Inter-Agency Task Force of COVID 19, as follows:

1. All Individuals Must wear Face Mask at all times without exception;
2. All Individuals Must wear Face Shield at all times without exception;
3. Seating arrangement within the school premises and drop-off / pick-up stations must be 2 meters in radius apart;
4. Everyone Must observe 1.5 meter Social Distancing at all time;
5. Everyone is encouraged to have personal pocket Sanitizers;
6. Must Wash Hands as often as possible;
7. It must be held outdoors;
8. Must disinfect the venue as often as possible;
9. Groupings shall only be limited to a maximum of Five (5) Individuals only observing the 1.5 meter Social Distancing at all times, and;
10. Crowding is strictly Prohibited.


