Context and Background

Save the Children Philippines (SCP), in partnership with the Department of Education (DepEd), has been advocating for the voice of children and youth, empowering them as change agents on the issues pertaining to their rights and well-being. In regards to climate crisis issues, SCP is aiming at continuously supporting children and youth with their initiatives and ideas to ensure that their voice reaches out from local to national stakeholders and international community. Addressing the current climate crisis, which is a children's rights crisis, through child rights-based approach was a highlight in several discussions with children and youth across the region in the year of 2020.

In line with the Save the Children's initiative to enhance programming and advocacy on climate action with children and youth's participation in the Asia Region, SCP in partnership with the DepEd, specifically the Disaster Risk Reduction and Management Service (DRRMS) and the Bureau of Learner Support Services – Youth Formation Division (BLSS-YFD) will be conducting "Children's Participation in Climate Action" survey. The purpose of the survey are as follows:

- To understand the level of awareness for children and youth in terms of impact of climate crisis on their rights and well-beings, and provide the educational opportunities and tailored contents for children and youth depending on level of knowledge and experience;
- To advocate for more opportunities and tackle the challenges of children when participating in climate activities, based on the needs of children and youth;
- To effectively address the rights of children and children's participation on climate related policy making process, based on reference of voice of children and youth.

Survey Methodology

The survey will employ stratified random sampling to ensure adequate representation of different groups of learners (region, school type, and grade level).

For the online survey, there will be randomly selected schools and learners from each DepEd Regional Office (DepEd RO) and from the Bangsamoro Autonomous Region of Muslim Mindanao (BARMM) Ministry of Basic, Higher and Technical Education (MBHTE). A self-administered questionnaire in a Survey Monkey link format was designed (see Annex 1) to gather the following data:

- 1) children's level of awareness and specific concern on climate crisis and its impact on their rights;
- 2) channel for information on climate crisis;
- 3) children's perception on their rights and role in combating against climate crisis;
- 4) opportunities and challenges when children participate in climate actions;
- 5) children's perception on the role of stakeholders (government, community, private sectors, international community, and children themselves); and
- 6) any recommendation for stakeholders.

The survey will be implemented from June to July 2021 with learner survey respondents from Schools Division Offices (SDOs) with a specific target group of children aged 10 to 17.

Based on the total number of Grades 5 to 12 learners for School Year 2020 - 21 (including SPED), a minimum sample size of **385** was derived using the formula to compute for very large population size [1]:



 $n = ((z\text{-score})^2 \times StdDev \times (1\text{-}StdDev)) / (margin of error)^2$ where:

For this survey, a sample size of 600 will be used to account for possible non-responses. Distribution of sample per stratum was based on proportion to total population. Breakdown per DepEd Regional Office is presented in table below:

Coordination will be through DepEd RO and BARMM MBHTE. Identified focal persons from these offices will disseminate the survey link to randomly selected learners from SDOs or district offices.

Scope of work and expected deliverables:

Below is the expected roles and responsibilities of SCP and DepEd:

Department of Education

- Authorize DRRMS and BLSS-YFD to be the lead units/offices within DepEd to engage in the survey;
- Assign a focal person from the identified units/offices above to coordinate for the survey and support the finalization of the survey protocol and tools;
- Identify relevant stakeholders from the DepEd Regional Offices (RO) and Schools Division Offices (SDOs) who will be mobilized in the conduct of the survey including seeking formal consent from the children's parents/guardians, and facilitate communication with them;
- Assist with the coordination during the conduct of the survey with the respective SDO personnel;
- Support the analysis, report writing and survey result dissemination to various fora.

Save the Children Philippines

- Assign a focal person from its identified units to coordinate for the survey with DepEd units/offices
- Support the development of the survey proposal and tools
- Cover the cost for the subscription of the survey platform (e.g., Survey Monkey) which will be utilized for the survey
- Provide support for the mobile data load allowance of identified personnel from the DepEd SDOs and of survey respondents, as applicable
- Mobilize staff from its field offices in conduct of survey to out of school children and youth, either
 online or through face to face (if local restrictions due to COVID-19 permit and in compliance with
 strict health and safety protocols)

The output of the partnership is a report of the analysis of the survey and a presentation file that will be disseminated to DepEd and SCP key stakeholders.

Benefits of the study:

Learners, girls and boys, teaching and non-teaching personnel engaged in programs that implement climate change adaptation and mitigation (CCAM). The data from this survey will be used to inform improvements to DepEd programs CCAM in schools, and the policies that enables better children's participation. There will be interventions targeted at each type of stakeholder, depending on the result of the survey.



Risks the survey imposes

Participants will not be exposed to a more than minimal risk during this study; they will also be given an opportunity to opt out of the survey before it starts. On the selection of survey respondents, SDO coordinators will be asked to communicate with the parents/guardians of the children to inform them of the survey. At the beginning of the survey, a consent script will provide students with an overview of the subject of the survey so they can make a well-informed decision about whether or not to participate. The script will verify that the survey respondents got a consent from their parents or guardians in participating in the survey.

Safeguards

The survey will be conducted using a safe and secure online survey service provider. No participants will be asked to provide any personal information.


Compensation for Participation in the Study
