#### GUIDELINES ON THE CONDUCT OF DIVISION SPG/SSG FEDERATION **ELECTIONS FOR S.Y. 2021-2022**

- 1. District Federation Presidents shall be grouped into congressional district clusters. They will be required to attend the scheduled virtual Cluster Assembly Meeting to discuss and organize the list of candidates to run for position in the Division Federation. Only elected District Presidents (or vice president representing their district) can be nominated for the post in the Division Federation. District representatives are allowed to vote for his/her desired candidate for the federation post.
- 2. Division Federation Officers shall be composed of the following:

- 3. The congressional cluster nominees shall be introduced during the miting de avance in the virtual platform where they will be given a maximum of 3 minutes to briefly present their plans and vision for running for office. An open forum will follow where other participants shall prepare questions on relevant issues for the candidates to answer. The miting de avance shall last only 3 hours. Candidates may post their campaign poster/materials on the specified media platform (strictly no vote-buying or any form of gratitude reward for voting).
- 4. All district elected presidents/representatives shall submit the following:
  - Certification that the participant is elected as District Federation President from PSDS/PICD/District SAC
  - Certificate of Candidacy (to be submitted after the congressional cluster assembly)
  - Parent's consent
- 5. The online election shall be held via online voting using Google Forms and the casting of votes shall start at 9:00 am to 10:00am. All qualified voters will be given an entry code uniquely theirs to get access to the polling system. The official result shall be released within an hour after closing of the online poll.
- 6. Induction of officers shall be held in the afternoon followed by a brief orientation.
