- Pursuant to OUA MEMO NO. 00-1221-0159 dated December 22, 2021 entitled WINS MONITORING PROGRAM FOR SY 2021-2022 which aims to ensure that all schools report and update their WINS status yearly with the use of the Three Star Approach (TSA)

- 3. Kindly refer to the following reminders for SY 2021-2022:
 - a. For schools that are part of the pilot implementation of face- to- face classes:
 - Fill out the WinS Monitoring Tool using the current school year's data for all indicators.
 - For schools that remain under remote learning modalities:
 - Use the SY 2019-2020 data for the non-applicable questions or refer to OUA Memo 00-0521-0145 dated 06 May 2021 for the guidelines on filling out the WinS Monitoring Tool.
 - For the questions on daily group handwashing activity (one of the 5 crucial indicators), use the SY 2019-2020 data or indicate that this requirement is met through the strict implementation of handwashing for everyone entering school premises.
