OBSERVANCE OF THE DRUG ABUSE PREVENTION AND CONTROL WEEK 2022

- 1. Pursuant to Presidential Proclamation No. 124, dated November 26, 2001 declaring the third (3rd) week of November every year as Drug Abuse Prevention and Control Week wherein the field is enjoined to celebrate in order to promote public awareness against the dangerous and ill-effects of drugs (Tobacco, Alcohol and illegal drugs) and to arouse public cooperation in the government's anti-drug campaign.
- 2. All elementary and secondary schools are encouraged to conduct relevant activities during the week-long celebration on the third week of November to be spearheaded by district/ school nurses and NDEP/BKD Coordinators.
 - 3. All PSDSs/PICDs, school heads and teaching and non-teaching personnel are asked to re-visit office or school policy on Drug-free workplace or schools, and give emphasis to the promotion of Drug (Tobacco, alcohol and illegal drugs) free workplace or school.
 - 4. Barkada Kontra Droga (BKD) school organization shall spearhead the activity in collaboration with school NDEP Coordinator, SPG/SSG officers and advisers. Inclusion and partnership with external stakeholders is highly encouraged. Activity completion report (ACR) shall be submitted to the division office thru the School Health and Nutrition Section not later than November 25, 2022.
