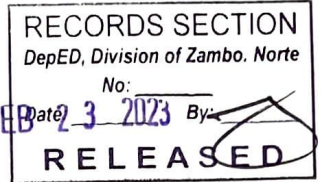

1. Pursuant to DepEd Order No. 40, s. 2015 *Guidelines on K to 12 Partnerships*, this office hereby directs all concerned to upload school partnership agreements such as Memorandum of Agreement (MOA), Memorandum of Understanding (MOU), Deed of Donation (DoD) and other similar documents entered into between the schools and their partners covering the period FY 2020 to FY 2022 not later than April 15, 2023 through the link <https://www.depedzn.net/link/1ed36c>.
2. These partnership agreements may include, but not limited to, the following:
 - a. Inputs into the curriculum and/or work immersion program which may include contextualization of the curriculum or design of work immersion program to make the program more relevant to the needs of the community;
 - b. Teacher and non-teaching training and capacity building;
 - c. Use and/or provision of facilities, equipment, technology and furniture
 - d. Provision of infrastructure, financial support, school supplies, policy support and technical assistance; and
 - e. Augmentation to human resource and wellness, health and nutrition programs
