

CONTRACT AGREEMENT

THIS AGREEMENT, made this SEP 06 2022 day of 2022, 2022 between **DepEd- SCHOOLS DIVISION OF ZAMBOANGA DEL NORTE**, Capitol Drive, Estaka, Dipolog City, Philippines (hereinafter called the "Entity") and **YSL BUILDER**, General Luna St., Dipolog City (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor executes the **"REPAIR AND REHABILITATION OF CLASSROOMS IN VARIOUS SCHOOLS OF ZAMBOANGA DEL NORTE DIVISION UNDER CY 2022 QUICK RESPONSE FUND – LOT 4"** (hereinafter called "The Project") with **Contract No. CB-2022-020** and the Entity has accepted the bid for **THREE MILLION, THREE HUNDRED THIRTY-EIGHT THOUSAND FOUR HUNDRED SEVENTY PESOS & 27/100 (P 3,338,470.27)** by the Contractor for the execution and completion of such Project, **ninety (90) calendar days** from the **date of receipt of the Notice to Proceed**, and the remedying of any defects therein.

 - (g) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - (h) Eligibility requirements, documents and/or statements;
 - (i) Performance Security;
 - (j) Notice of Award of Contract and the Bidder's conforme thereto;
 - (k) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to execute and complete the Project and remedy any defects therein in conformity with the provisions of this Contract in all respects.


